# White House Community Policing Proposal & Follow-On Meeting with Acting Associate AG Delery

On December 1, 2014, the White House announced a \$263 million community policing proposal to foster trust between law enforcement officers and the citizens they serve.

The largest chunk of the spending package calls for \$75 million to help law enforcement agencies buy body-worn cameras for police via a grant program. The White House estimates a \$15 million first-year investment in the program could help purchase up to 10,000 body-worn cameras, with a total of 50,000 cameras covered over the full three years.

The White House also wants \$55 million for the Justice Department's existing smart policing initiative, which offers grants for police departments to work with research partners to better meet community needs using crime data. According to the Administration, the investment could serve at least 20 communities over three years. The funding would also support the creation of a program to increase knowledge on the use of body-worn cameras.

In addition, the White House is calling for a separate \$55 million allotment for state, local, and tribal courts and juvenile justice agencies to work toward improving public trust in the criminal and juvenile justice systems.

Finally, the Administration wants \$2 million to support its proposed task force on how to effectively reduce crime while building public trust. President Obama is expected to create the task force in an executive order. The "21st Century Policing" task force will be led by Philadelphia Police Commissioner Charles H. Ramsey and Laurie Robinson, a professor at George Mason University and former assistant attorney general at the Department of Justice. The task force will include law enforcement officials and community leaders. It will work with Justice's existing Community Oriented Policing Services office and will be tasked with making recommendations within 90 days of its creation.

NAPO discussed the above proposals at great length during a meeting with Acting Associate Attorney General Stuart Delery on December 4, 2014. We will continue to stay engaged with the White House and the Department of Justice to ensure that the rank-and-file perspective is heard loud and clear as the proposals proceed.

# NAPO Meets with Senate Majority Leader Harry Reid's Staff to Express Support for the James Zadroga 9/11 Health and Compensation Reauthorization Act

On December 3, 2014, NAPO participated in a meeting with **Senate Majority Leader Harry Reid's (D-NV)** staff to express our strong support for S. 2844, the James Zadroga 9/11 Health and Compensation Reauthorization Act.

The Zadroga bill's two critical programs providing medical treatment and compensation for 9/11 heroes – the World Trade Center Health Program and the September 11th Victim Compensation Fund – are set to expire in October 2015 and October 2016 respectively. This legislation would continue these programs for 25 more years, through 2041.

9/11 responders and survivors are still battling serious health crises resulting from exposure to the toxins at Ground Zero. More than 30,000 9/11 responders and survivors have an illness or injury caused by the attacks or their aftermath, and over two-thirds of those have more than one illness. Many are disabled and can no longer work. They are suffering from a host of chronic diseases: asthma, obstructive pulmonary disease and gastroesophageal reflux disease, and many more.

Medical research has identified more than 60 types of cancer caused by 9/11 toxins. More than 2,900 people have been diagnosed with cancers caused or made worse by the aftermath of the attacks - more than 800 New York Fire Department members and more than 550 New York Police Department personnel are struggling with serious 9/11-related illnesses, not including the more than 70 firefighters and 60 NYPD officers who have died from their 9/11-related illnesses.

Responders came from all over the country to aid in the response to the attacks. And some area residents, workers, and survivors have since moved and are currently receiving care in cities and states across the country. Participants enrolled in the World Trade Center Health Program for treatment currently reside in all 50 states and in 429 of the 435 Congressional districts in the country.

These heroes put their lives on the line to serve us, and must be afforded every resource available as they cope with chronic health conditions caused by exposure to toxic chemicals at the World Trade Center.

This legislation will also honor those who made the ultimate sacrifice to protect our nation. James Zadroga, a New York City Police Department Detective and member of NAPO, died of respiratory disease caused by his exposure to toxic chemicals at Ground Zero. It is our obligation and duty to remember these heroes and ensure that survivors who risked their lives to protect us continue to receive the treatment and compensation that they deserve.

# NAPO Responds to Members of Congress Who Made "Hands-Up" Gesture on House Floor

Over the past week, four members of Congress made the "Hands up, don't shoot," gesture on the floor of the House of Representatives. NAPO sent letters to each of the members, (Congressman Hakeem Jeffries (D-NY), Congresswoman Yvette Clarke (D-NY), Congressman Al Green (D-TX), and Congresswoman Sheila Jackson Lee (D-TX)), to express concern and outrage over these actions. These actions are not only disrespectful to law enforcement officers, who put their lives on the line every day to protect our nation, but they are also harmful to communities that are trying to heal after weeks of unrest.

NAPO used the letters to stress that physical evidence has clearly shown that Michael Brown was not attempting to surrender with his hands in the air. Three separate autopsies, including one at the request of Mr. Brown's family, showed that the shots which struck Mr. Brown did so when Mr. Brown was facing and/or in direct physical contact with Officer Wilson. There were no shots while Mr. Brown's hands were up over his head, and further evidence proved that Mr. Brown must have been moving toward Officer Wilson when shot, not away from him. The symbol that was gestured on the House floor is not based on truth.

We have accepted the fact that social media will continue to spread false claims about events in Ferguson, but we are shocked and dismayed that members of Congress would fuel tension in communities across the country by making false statements on the House floor.

NAPO urged the members of Congress to stop ignoring the evidence in this case. As our officers are working to strengthen relationships with the communities that they serve, we hope that members of Congress will work with us to restore peace to communities across the nation.

# NAPO Joins Congressman McNerney to Press For More Funding for Law Enforcement Hiring and Technology

On December 3, 2014, **Congressman Jerry McNerney (D-CA)** sent a letter to House and Senate appropriators, asking them to include additional money in the latest government funding bill for law enforcement agencies to hire more officers and purchase needed technologies.

The letter to the chairmen and ranking members of the House and Senate Appropriations Committees asks them to include robust funding for the COPS (Community Oriented Policing) Technology Grants and Hiring programs in any FY 2015 spending bills passed by the two chambers. Congressman McNerney's letter was co-signed by 47 of his House colleagues, including Congressmen Dave Reichert (R-WA) and Bill Pascrell (D-NJ).

NAPO expressed our support for Congressman McNerney's initiative. The Congressman included NAPO's statement in his press release on the funding request:

"The National Association of Police Organizations (NAPO) applauded Rep. McNerney's work on behalf of law enforcement: 'NAPO, which represents 241,000 sworn law enforcement officers from across the country, is a staunch advocate of the COPS Hiring Program,' said Bill Johnson, Executive Director of NAPO. 'This critical program provides resources to put more police officers on the street, which allows officers to build strong relationships with the communities they serve. NAPO will continue to advocate for increased funding of this vital program, which contributes to increased public safety in communities across the nation.'"

# NAPO Participates in Comprehensive Law Enforcement Review Project Teleconferences

NAPO is involved in a comprehensive law enforcement review project, which was initiated in response to a proposal, co-authored by NAPO, recommending a criminal justice review. The Attorney General requested the COPS Office to lead the project, with input from a diverse group of law enforcement stakeholders.

The goal of the project is to create a foundational document that provides an overview of key developments and challenges in American law enforcement, focusing on the last fifty years. Over the past week, NAPO has participated in the following teleconferences to move the project forward:

- <u>Policy Reform & Implementation</u>: Topics that are being reviewed include: information sharing; federal grant programs; law enforcement and immigration; uniform crime reporting; and the Smart on Crime Initiative.
- **Future of Policing**: Topics that are being reviewed include: policing in a new economy; collaboration and partnerships; developing effective leaders; police agency of the future; and recruitment, hiring & retention.

• <u>Alternatives to Incarceration & Strategies for Reentry</u>: Topics that are being reviewed include: first offender deferral programs; restorative justice; role of law enforcement in reentry; and mental health.

As we move forward, we will continue to strongly advocate that the rank-and-file perspective be included in the project review. NAPO will keep our members updated as the project moves forward.

# **Bill Cassidy Defeats Senator Mary Landrieu in Runoff Election**

# **Online ARIDE Training Available**

President Obama has proclaimed December National Impaired Driving Prevention Month. In light of this announcement, the Office of National Drug Control Policy has requested we share the following information on the Advanced Roadside Impaired Driving Enforcement (ARIDE) program.

### **Online ARIDE Training Available**

Enhance your ability to recognize the signs of impairment from drugs, alcohol, or both.

The Advanced Roadside Impaired Driving Enforcement (ARIDE) program was developed by the National Highway Traffic Safety Administration (NHTSA).

The ARIDE program bridges the gap between the Standardized Field Sobriety Testing (SFST) and the Drug Evaluation and Classification/Drug Recognition Expert (DEC/DRE) programs by providing officers with general knowledge related to drug impairment and by promoting the use of DREs in states that have the DEC Program. With shrinking budgets, law enforcement executives have to make difficult decisions to do more with less. They can no longer afford to have law enforcement personnel out of the office for a substantial period of time. The online version of the ARIDE program enables more law enforcement personnel to take the course while not missing valuable time from their duties.

The online course has the same content as the in-person course, and will train law enforcement officers to observe, identify, and articulate the signs of impairment related to drugs, alcohol, or a combination of both.

#### Dear Congressman Jeffries:

On behalf of the National Association of Police Organizations (NAPO), I write to you to express our extreme disappointment and concern over your decision to make the "Hands up, don't shoot," gesture on the floor of the House of Representatives.

NAPO is a coalition of police unions and associations from across the United States that serves to advance the interests of America's law enforcement through legislative and legal advocacy, political action, and education. Founded in 1978, NAPO now represents more than 1,000 police units and associations, 241,000 sworn law enforcement officers, and more than 100,000 citizens who share a common dedication to fair and effective crime control and law enforcement.

Your actions are not only disrespectful to law enforcement officers, who put their lives on the line every day to protect our nation, but they are also harmful to communities that are trying to heal after weeks of unrest. Much of the community tension that we have witnessed has been caused by false statements about events in Ferguson, which you continue to perpetuate on the floor of the House of Representatives.

Physical evidence has clearly shown that Michael Brown was not attempting to surrender with his hands in the air. Three separate autopsies, including one at the request of Mr. Brown's family, showed that the shots which struck Mr. Brown did so when Mr. Brown was facing and/or in direct physical contact with Officer Wilson. There were no shots while Mr. Brown's hands were up over his head, and further evidence proved that Mr. Brown must have been moving toward Officer Wilson when shot, not away from him. The symbol that you gestured on the House floor is not based on truth.

We have accepted the fact that social media will continue to spread false claims about events in Ferguson, but we are shocked and dismayed that a member of Congress would fuel tension in communities across the country by making false statements on the House floor.

We urge you to stop ignoring the evidence in this case. It is your job to inform the public and pursue legislation that is in the best interest of the nation, not to repeat false statements that will only create more unrest in our communities. As our officers are working to strengthen relationships with the communities that they serve, you are fostering continued conflict. You are not spreading the truth. You are creating havoc and unrest.
